## CORRIGENDUM

In continuation to this office order No. CCFD/326 dated 17.06.2025, the Department of Forest & Wildlife, UT Chandigarh is starting the initiative "वन विभाग आपके द्वार" (Forest Department at your Door Steps) on the Occasion of 'Van Mahotsav-2025' during the monsoon season in UT Chandigarh. The scheme (**Distribution of plants/saplings to general public without any formal application**) thereby eases the participation of different stakeholders in the greening efforts and hence help the Forest Department in achieving its objectives.
